Policy

Participation Waiver, Release & Acknowledgment of Risk

By enrolling my child(ren) in Rocky Mountain Enrichment ("RME"), I acknowledge, understand, and agree to the following:

Assumption of Risk

I understand that RME enrichment activities—including but not limited to indoor and outdoor play, nature exploration, gym use, crafts, science experiments, and off-site field trips—involve inherent risks of injury or illness. I voluntarily accept and assume all such risks, including those that may arise from the ordinary negligence of RME, its owners, staff, independent contractors, volunteers, agents, Meadows Park Community Center (MPCC), Colorado Homeschool Enrichment (CHE), and any partner venues.

Release & Waiver of Liability

In consideration of my child's participation, I hereby **release**, **discharge**, **and hold harmless** RME, its owners, staff, independent contractors, volunteers, agents, MPCC, CHE, and any partner venues from any and all claims, demands, or causes of action for injuries, damages, or losses arising from ordinary negligence related to my child's participation in RME activities.

Indemnification

I further agree to **indemnify and defend RME** and its representatives against any claims brought on behalf of my child(ren) that result from my own negligence, willful misconduct, or failure to comply with RME policies.

Emergency Medical Consent

I authorize RME personnel to secure emergency medical, dental, or surgical treatment deemed necessary for my child(ren), including hospital admission and the release of medical information to treating providers. I agree to accept full financial responsibility for any such treatment, including ambulance or rescue transport if required.

Insurance Responsibility

I understand that RME does **not provide medical or accident insurance** for participants. I am responsible for maintaining adequate insurance coverage for my child(ren).

Field Trip & Off-Site Events

I acknowledge that transportation to and from off-site field trips is the responsibility of parents/guardians. I am responsible for my child's safety during travel. I grant permission for my child(ren) to participate in RME field trips and off-site events. I understand that details of each event will be provided in advance and that parent attendance is required unless otherwise noted.

Choice of Law & Venue

This agreement shall be governed by and construed under the laws of the State of Colorado. Any disputes shall be resolved exclusively in a court of competent jurisdiction in El Paso County, Colorado.

Severability

If any provision of this agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Authority to Sign

I certify that I am the parent or legal guardian of the enrolled child(ren) and that I have full authority to accept this waiver and release on their behalf.

Acknowledgment of Understanding

By electronically accepting this agreement in the **Parent Portal**, I confirm that I have carefully read this entire document, fully understand its terms, and understand that I am giving up certain legal rights on behalf of my child(ren) and myself. I accept these terms freely and voluntarily as a condition of my child(ren)'s participation in Rocky Mountain Enrichment programs and activities.
